SECTION 7. HANDLING AND STORAGE

7.1 PRECAUTIONS FOR SAFE HANDLING:
 Isolate from oxidizers, heat, & open flame. Use only with adequate ventilation. Avoid prolonged or repeated breathing of vapor or spray mist. Do not get in eyes, on skin or clothing.
